# 9. Executive Committee Report

President Davis provided the Executive Committee meeting report.

### A. TACC Bylaws; possible amendment and term of office

Presenter: Kim Rutledge, State Adult Protective Services (APS) Liaison, California Department of Social Services

Kim Rutledge presented a review of Mandated Reporting requirements and the role of CDSS.

- PSA 12 Jim Grinnell asked, "What does geographically isolated mean?" See Department of Housing and Community Development. Many have poor water, no electricity; a large percentage of Alpine County's residents are in those circumstances.
- PSA 14 Minerva Garcia reported the Advisory Council is working to help people prepare for disasters. Looking at the need for housing options upon release from the hospital. Fresno has the money to expand technology training to the rural communities.
- PSA 15 Bobbi Wartson announced a second Meals on Wheels fund-raiser and a local conference to share information on the Long-Term Care Ombudsman.
- PSA 18 Toni Olson shared a publication put out by the local aging foundation (VCAAA.org) with information of interest to the community. The group recently started a "Get a Job" workforce committee where members are being trained to speak on how to get a job, provide job training and tips.
- PSA 19 Gene Dorio reported on new efforts around the Coronavirus. The CDC met with the county this week. Flu is serious this year; need to make sure people are getting flu shots. Working to fight rent increases with county's legal resources.
- PSA 20 David Wilder reported San Bernardino is a Home Safe county. He made an APS referral and was able to get an elderly couple to safe housing.
- PSA 21 Art Salyer did not have additional information to add to his written report.
- PSA 22 Elizabeth Busick reported that 1,166 Orange County seniors have been enrolled in CalFresh since January. Meals on Wheels drivers are conducting technology surveys to gather data on computer use/access.
- PSA 23 Rosemarie Bahmani reported on listening sessions underway in preparation for the Area Plan. There has been a great response; very interested attendees offering good ideas.
- PSA 29 Tita Bladen asked if others have been told the County Supervisors shouldn't attend meetings at risk of undue influence. Wilder pointed out the open meeting issue.
