10. Pilot Project Concept: Aging Lesson Plan for High School

Presenter: Demetria Rivera, CCoA Gerontology Intern

Ms. Rivera provided a PowerPoint presentation on an aging lesson plan, pilot project concept for 9th graders.

TACC member suggestions and comments include:

- Introducing at the 9th grade levels and reinforcing at 11th grade for those applying to college and looking for possible careers geared toward field of aging.
- Including young people in their advisory councils.
- Intergenerational day care program to include kids and seniors
- Teach empathy and sympathy for those struggling now.
- Learn to be an advocate for older adults.

- Have students watch tv programs and come up with examples of ageism.
- Teach about planning for every phase of your life.
- Anti-bullying ties into having a measure of respect and kindness for all.

PSA 6 - Diane Lawrence

- PSA 7 Jim Donnelly suggested mobile vaccinations be provided to address the challenge of reaching underserved communities.
- PSA 10 Sam Saiu reported his Advisory Council is reviewing the Area Plan. Public hearings will be held this afternoon. Working on digital inclusion and access to devises such as tablets and smart phones for telemedicine appointments.
- PSA 12 Lynne Standard-Nightengale reported Amador County is putting together a team consisting of behavioral and mental health professionals to provide services in rural areas.
- PSA 15 Bobbie Wartson announced the yearly charity golf tournament will be held in May.
- PSA 18 Toni Olson discussed the success of the robotic pet program for dementia patients.
- PSA 19 Gene Dorio reported vaccinations for seniors as a high priority. Last week only 23% of seniors were vaccinated working on getting vaccines distributed to those at home. A new kitchen facility was built for food service delivery to seniors that can prepare 1200-1300 meals a day.
- PSA 20 David Wilder reported on March 17 the Seniors Affair Commission will hear from the California Department of Aging with an Area Plan Update. The Advisory Council will review and comment on the plan as part of the Older American's Act.
- PSA 22 Larry Kramer has nothing to add to the written report.
- PSA 23 John Osborne reported a significant turnover on the Board of County Supervisors. There are three new County Supervisors each can appoint two new Advisory Council members. Four members have already termed out. Meal deliveries are up 40% from last year. No written report was submitted.

PSA 26 - Paul Branson reported a new Federal FCC emergency broadband program that provides discounts for internet service for low-income individuals including seniors.

PSA 27 - Cynthia Scarborough has nothing to add to the written report.

PSA 28 - Richard White asked when others were planning to resume in-person meetings. The advisory council had good applicants for Solano County vacancies but had difficulty finding Napa applicants. The AAA has \$150,000 extra for nutrition services.

12. Amanda Lawrence, MPH, Project Director, Master Plan for Aging, California Department of Aging

Ms. Lawrence provided an overview of the Master Plan for Aging (MPA), which takes a life-course approach to aging in California. She reviewed several MPA initiatives slated for implementation early this year.

13. Update on COVID-19 Vaccination Outreach

Presenters: Ron Chapman, MD, MPA, and Sonya Harris, Senior Advisor, CDPH COVID-19 Vaccine Task Force

Dr. Chapman and Ms. Harris reviewed the number of COVID-19 cases and deaths in California and noted the high impact on older adults and on Black, Latino, and Native American populations. The state has prioritized high-risk groups for vaccination and was administering 1.5 million vaccinations a week, with 10.5 million administered to date.
