8. President's Remarks

President Wartson thanked TACC members for participating in today's call.

9. Staff Report

- a) CCoA Executive Director Swartzlander provided the following staff report:
 - Housing and Homeless Forum, on May 9th in Glendale. TACC members are invited to participate via Zoom.
 - Peter Anderson has been hired and will begin in May as a retired annuitant for CCoA, providing general staff support and a focus on policy and procedures.
- b) CCoA staff provided the following legislative update regarding CCoAsponsored bills:
 - AB820 (Reyes) Increasing representation of older adults in the state's decision-making spaces. The bill is scheduled for hearing in the Assembly Appropriation Committee on May 3rd.

- *AB770 (Kalra) RCFE Expansion and Housing elements.* The bill has been amended significantly, and CCoA staff will continue to work with the author and committee staff to identify language that will allow the bill to move forward. The bill is currently in the Assembly Appropriations Committee.
- *SB544 (Laird) Bagley Keene Requirements.* Despite opposition, the bill is making its way through the policy hearing process and is currently in the Senate Appropriations Committee.

10. Overview of the Travel Claiming Process

Staff reviewed CCoA's Travel Expense Claim policy, provided a PowerPoint presentation, and discussed the location of forms, when excess lodging forms are required, first-time reimbursement requirements, mileage reimbursement, and per diem rates and common mistakes.

11. Presentation: Village Movement California: Building Intergenerational Communities of Care

Charlotte Dickson, Executive Director, Village Movement California (VMC), and Carolyn Ross Village, Communications Incubator Coordinator, discussed the value of the village concept and reported that there are currently 45 villages operating within 20 of the 35 Area Agencies on Aging (AAAs) across the state. Background and availability of resources of the Village Incubator Program was provided, as well as a discussion of the recently launched Diversity, Equity, Inclusion, and Belonging Institute.

12. Presentation: AB 567 Feasibility Report Overview

Dustin Plotkin, FSA, MAAA, ACIA, Principal, Oliver Wyman

Actuary Dustin Plotkin provided an overview of work accomplished pursuant to AB 567 (Calderon, Chapter 746, Statutes of 2019), which established the Long-Term Care (LTC) Insurance Task Force (Task Force) to explore the feasibility of a statewide LTC program. The Task Force is required to examine the components necessary to design and implement a statewide LTC insurance program and recommend options for establishing this program in a report submitted to the commissioner, the Governor, and the Legislature by July 1, 2021.
