# 9. California Department of Aging (CDA) Update

**Adam Willoughby**, Assistant Director for Legislative Affairs, CDA Willoughby discussed the legislative work happening currently at the California Department of Aging. Nineteen bills are being reviewed, including SB 1249. CDA is working with CCoA and the author of SB 1249 (Senator Roth) to adopt recommended amendments. CDA appreciates CCoA's leadership on the bill and is confident its passage will usher in a new era of high quality, consistent, and integrated services for Older Californians.

10. Presentation: Best Practices - Area Agencies on Aging Advisory Councils Victoria Jump, Director, Ventura County Area Agency on Aging Jump discussed the Ventura County Master Plan for Aging and the different initiatives and committees they have formed with their advisory council.

**Maria Profeta**, Manager, Stanislaus County Aging & Veteran Services Profeta discussed the actions that Stanislaus County has taken to combat older adult homelessness. Actions included developing their HomeShare program and implementing supplemental rental subsidies for older adults struggling with homelessness.
